**Distance/Accuracy/Freestyle Tie-Breaker** If there is a tie for first, second, or third place, the tie will be broken by the following criteria, as necessary: 1) The competitor with the highest combined scores in the Athleticism and WOW!FACTOR categories from the Freestyle Rounds, 2) The contestant with the highest score in Distance/Accuracy, 3) A *Face-off* round will take place with each team receiving one Distance/Accuracy throw. The dog making the higher scoring catch will be declared the victor. If the teams are still tied after each has made one throw, *Face-off* continues until one dog makes a higher scoring catch than the other. Officials will permit the competitors to rest their dogs as necessary.
